Data Privacy Statement of the Dusseldorf Branch office of JFE shoji trade corporation

The protection of personal data is of great concern for us. That is why we operate this website in conformity with the applicable legal provisions for the protection of personal data and for data security. It is explained below what information we collect on this website, for what purpose it is used and to whom it is possibly made available. This data privacy statement will be adjusted from time to time.

Data collected and purpose of processing

During the visit to this website, using so-called "cookies" (see below) data is automatically recorded concerning the number of times this site was accessed. This data includes, for example, browser type and version, date and time of access, anonymized IP address and pages visited within the website. This data cannot be allocated to any particular individual. For the statistical evaluation of this anonymized data, the web tool Google Analytics is used. This serves the improvement and optimum design of our website. The data generated is secured on the webserver at our data center.

Moreover, the webserver saves connection data that is logged only for security analyses and to ward off attacks. In this case, apart from the IP address, as a matter of principle, no personal data is collected and used. Evaluation of IP addresses is carried out only in the event of an attack. This data is likewise secured on the webserver at our data center.

Personal data

Moreover, we collect personal data (e.g. names, addresses, telephone numbers or e-mail addresses) in connection with the operation of our website only if you place such data at our disposal voluntarily (e.g. by contact requests etc.) and we are entitled to use it on the basis of consent granted by you or based on a statutory regulation concerning its processing or utilization.

We make use of this data, as a matter of principle, only for the purpose for which you placed the data at our disposal. That means to answer your inquiries, to process your orders or to give you access to certain information or offers.

Passing-on data

The passing-on of data takes place solely within the scope of and with observance of the applicable legal provisions. We will not sell your personal data to third parties, nor will we market it elsewhere.

How we use cookies

When you visit our website, information is deposited on your terminal device in the form of a "cookie". Cookies are small data files which are saved on your terminal device and save certain settings and data for exchange with our pages via your browser.

As a matter of principle, we do not collect any personal data by means of cookies. If you do not want us to recognize your terminal device, please set your internet browser in such a way that it deletes cookies from your device, blocks all cookies or warns you before a cookie is stored. Please note that without cookies certain functionalities of our website possibly no longer function or no longer function correctly.
