Groundbreaking ceremony for electrical steel sheet processing and sales company in the Republic of Serbia

JFE Shoji Corporation (President and CEO : Toshinori Kobayashi ("the Company") is pleased to announce that the groundbreaking ceremony for the newly established JFE Shoji Serbia d.o.o. Beograd ("JSS") for electrical steel sheet processing and sales company was held in Indjija City, the Republic of Serbia ("Serbia").

1. About the groundbreaking ceremony

The groundbreaking ceremony was held on March 18 and was attended by approximately 50 persons, including Mr. Aleksandar Vucic, President of the Republic of Serbia, Tomislav Momirovic, Minister of Domestic and Foreign Trade, Mr. Vladimir Gak, Mayor of Indjija, and Mr. Akira Imamura, Ambassador, Embassy of Japan. From the Company, Mr. Kobayashi, Executive Vice President, and Mr. Hamauzu, President of JSS, attended the ceremony and prayed for the safety of the plant construction work.

"We believe that our new factory with the latest technology will certainly contribute to the automotive, appliances and electrical machinery industries in Serbia and Europe," Kobayashi, Executive Vice President said in a speech. "We are determined to establish a new plant in Europe for the first time." Mr. Vucic, President of Serbia commented that "this investment is very important for Serbia as well, and I promise maximum support."

2. About Establishment of a new plant

In Europe, demand for motor cores is expected to expand due to increased demand for electric vehicle driving motors in response to tough environmental regulations toward achieving carbon neutrality by EU in 2050 and increased demand for automotive motors used to improve automotive functions and convenience.

Serbia, where we establish a new plant, is located near the center of the Balkan Peninsula and has borders with many Eastern European countries.

Due to its prime location as a production base, many companies in the automotive manufacturing and electric vehicle related industries have entered the market in recent years.

We intend to establish No. 1 position in global processing and distribution of electrical steel sheet as a key issue for our Seventh Medium-Term Management Plan.

In addition to our global four key regions in Japan, the Americas, China, and ASEAN, we establish a processing and sales base in Serbia as a base of Europe which is a growing market and build a supply chain management. In this way, we will capture the growing demand for motor cores in Europe and strengthen our business to realize No. 1 position in global processing and distribution of electrical steel sheet.
