Merger of JFE Shoji Trade Steel Construction Materials Corporation and JFE Shoji Usuitakenzai Corporation

JFE Shoji Trade Co., Ltd. (President: Naosuke Oda) has decided to merge its group companies, JFE Shoji Trade Steel Construction Materials Corporation (Head office: Chiyoda-ku, Tokyo, President: Satoru Iino) and JFE Shoji Usuitakenzai Corporation (Head office: Chiyoda-ku, Tokyo, President: Yoshitaka Omura) in order to build a system that will more satisfy customer needs in the domestic construction industry.

The merger will be an absorption-type merger with JFE Shoji Trade Steel Construction Materials Corporation as the surviving company, and the company name will be “JFE Shoji Trade Steel Construction Materials Corporation”. The new system is scheduled to start from April 1st, 2020.

At present, JFE Shoji Trade Steel Construction Materials sells steel materials for building construction and civil engineering construction, and also engages in steel frame construction and deck construction business. JFE Shoji Usuitakenzai sells steel sheet materials for roof and wall construction.

By merging the two companies, we will unify the know-how and functions of each other in the construction field. That enables to provide “One-stop service” such as offering information to customers and expanding our product lineup in the field of construction steel materials. We will adapt quickly to the changing environment and satisfy the various customer needs in the domestic construction industry.
